

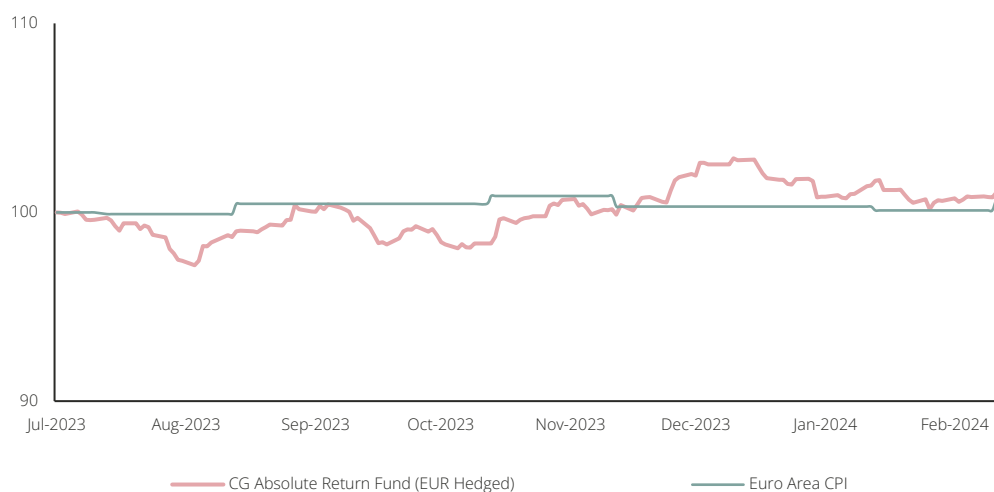

Performance Since Inception (total return)



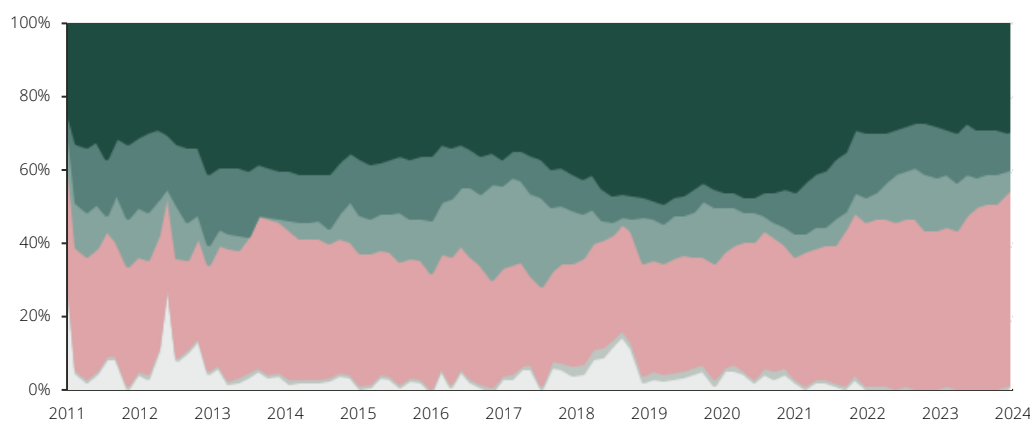
