### What is this product?

<b>Type</b>	The Fund is an approved sub-fund of the Company which is authorised as a UCITS by the Central Bank of Ireland.
<b>Objectives</b>	<p>The investment objective is to achieve long term capital appreciation and income growth by investing mainly in US Government and corporate Index Linked Bonds, in particular Treasury Inflation Protected Securities (TIPS).</p> <p>The Fund is actively managed and is not actively managed in reference to a benchmark.</p> <p>The asset allocation is expected to be 100% in TIPS. The duration and therefore the volatility of the portfolio will vary over time. From time to time other investment grade government, government agency and corporate fixed interest bonds will be included in the allocation.</p> <p>The Investment Manager will utilise derivative instruments in hedged share classes.</p>
<b>Intended Investor</b>	The Fund is suitable for investors seeking capital appreciation with a medium to long term investment horizon and who are prepared to accept a moderate level of volatility. The Fund may not be suitable for any investor who requires their money within three years.
<b>Term</b>	This Fund is an umbrella type open-ended UCITS and this product is not subject to any fixed term. CG Asset Management Limited may not terminate the Fund unilaterally. Further information on the termination provisions relating to the Fund is available in the Company's Prospectus and constitutional documents.

### What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the capacity for you to receive a positive return on your investment.

#### Table 1: Costs over time

## How long should I hold it and can I take my money out early?

**Recommended holding period: 5 years**

The fund has daily liquidity. The recommended holding period of the fund is 5 years and it assumes the fund being the sole or majority holding of the investor. The recommended holding period is primarily based on the historic volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes.
